# Traverse County Commission Regular Board Meeting January 16, 2024

The meeting was called to order at 10:09 a.m. by Commission Chair Mark Gail. Other Commissioners present were Jerrel Olson, Dwight Nelson, Chad Metz, and Kayla Schmidt. The Pledge of Allegiance was recited. The agenda was approved unanimously with the following additions: Contract for Medical Examiner Services with Anoka County, upon a motion by Schmidt and second by Olson. There was no conflict of interest expressed. The January 2, 2024, regular Board minutes were unanimously approved upon a motion by Metz and second by Nelson.

# **Highway Department**

Brian Koch, Highway Supervisor appeared before the Board with a department update. Information was mailed out to the Townships for the Annual meeting on February 15. The Bombardier will be auctioned on MinnBid beginning January 15 and closing January 24, 2024.

#### Auditor/Treasurer

Auditor/Treasurer Kit Johnson appeared before the Board with a department update. January activities include year-end reporting, system updates, delinquent tax notices, and the administration of the Presidential Primary. There was a discussion regarding the Traverse Care Center and Prairieview Place funds. With the tax revenue that will be coming in and the state money we will end the year with a positive balance if there are no unknown expenses, but we need to keep a positive balance in those funds throughout the year. Upon a motion by Nelson and second by Jerrel a loan of \$100,000 to the Traverse Care Center fund and \$25,000 to the Prairieview Place fund was approved unanimously.

## **County Attorney**

County Attorney Matt Franzese appeared before the Board. Looking for approval to file an eviction notice for a person who moved into a tax-forfeited, substandard building located at 538 2<sup>nd</sup> Ave. NW in the City of Browns Valley. There was a motion by Schmidt to file an eviction notice, seconded by Metz, and approved unanimously. Franzese mentioned that this is the only property in Browns Valley that is tax-forfeited with a substandard building on it. The Commissioners were given a draft Resolution Extending the Interim Ordinance Placing a Moratorium on the Issuance of Conditional Use Permits for the Construction of Wind Energy Conversion Systems in Traverse County, Franzese asked that they look it over and they can discuss it at the Public Hearing February 6. Franzese also gave the Board a draft Ordinance Regulating Tetrahydrocannabinol Products Within the County of Traverse to look over. Schmidt and Olson will meet with Franzese to look over other counties' ordinances and see what modifications are needed. Franzese also brought forward a Resolution in Opposition to Redesigning the Minnesota State Flag and Seal. Discussion followed with the decision to wait for Franzese to get more information and bring this forward at the next meeting.
